

## Support for Grandparents

**N**orth Shore Child & Family Guidance Center knows that real healing comes from supporting the entire family. That's why we run two programs for grandparents: GASAK, for Grandparent Advocates Supporting Autistic Kids, and C-GRASP, for Caregiver Grandparent Respite and Support Program.

GASAK's mission is to support, inform and advocate for grandparents with autistic grandchildren. At monthly meetings, GASAK participants share information on issues critical to families impacted by autism.

While there are many programs for parents of autistic kids, few address the specific issues that come up for grandparents, but at GASAK meetings, grandparents can share their concerns with their peers.

GASAK member Judy Greenberg says, "A lot of times your friends can't relate



to what you're going through, but when you walk into the GASAK group, you feel comfortable instantly."

Guest speakers, such as education lawyers, play a vital role at GASAK meetings. "When a grandparent leaves a meeting," says Dr. Sue Cohen, Director of Early Childhood and Psychological Services at the Guidance Center, "they walk away with information that can make a huge difference in the lives of their children and grandchildren."

But the camaraderie members experience is perhaps the most important benefit of the group.

"There is such compassion," says one GASAK member. "By sharing our worries as well as our happy moments, we give new members hope."

### Grandparents In Charge

For a variety of reasons, sometimes grandparents are placed in the role of primary caregiver. That's when C-GRASP comes in.

Dr. Nellie Taylor-Walthrust, Director of the Guidance Center's Leeds Place, says these grandparents are often isolated, struggling with health and financial issues that add stress to the entire family.

Through partnerships with supportive local entities, the Guidance Center

provides the grandparents with a variety of services, including counseling, housing help and school advocacy.

"The grandparents also have the opportunity to develop a social network with other grandparents who are experiencing the same life challenge," says Taylor-Walthrust.

For the past eight years, Marie and Roger Dextra have been caring for their five

grandchildren because of their daughter's depression. Through C-GRASP, which is funded largely through the Town of North Hempstead's Department of Aging, Guidance Center advocates go to the children's school meetings on their behalf.

Despite the many hardships, the Dextras find joy in caring for their grandchildren. "It's such a passion for me," Marie says. "When I see them coming, I'm happy."

With both C-GRASP and GASAK, the Guidance Center's inclusive family approach helps create an environment in which children thrive!

# Donor Profile: Rosemarie and Mitchell Klipper

Rosemarie Klipper first learned of North Shore Child & Family Guidance Center's work when she was volunteering at Park Avenue Elementary School in Westbury. Her friend Bonnie Eisler, who was a supporter of the Guidance Center, told her about the organization, and Rosemarie immediately realized how beneficial our programs could be to the Westbury community.

"I hoped to learn how to bring services to the students at Westbury, as many were immigrants with multiple stresses in their young lives," she says.

The connection between Rosemarie and the Guidance Center has been a strong one for many years, as she and her husband Mitchell are involved at every level, always giving of their time, financial resources and creative ideas. Rosemarie has been a very active member of our Board of Directors for 15 years, and the couple has chaired our annual gala twice, as well as been our gala honorees in 2008.

"Rosemarie and Mitchell have a deep understanding about the importance of the Guidance Center's work," says Nancy Lane, Past President of the Board of Directors. "Giving back to the community and the larger world is an essential part of who they are, and they give from the heart."

## Family First

The Guidance Center is blessed to be among the many causes that receive donations from the Klipper Family Foundation, including Island Harvest, UJA-Federation, PJ Library and their synagogue, the Woodbury Jewish Center. The Foundation's mission—to support the Jewish people, alleviate hunger, promote literacy and provide mental health services to children and their families—puts family and community first, and that perfectly aligns with the Klipper's own values.

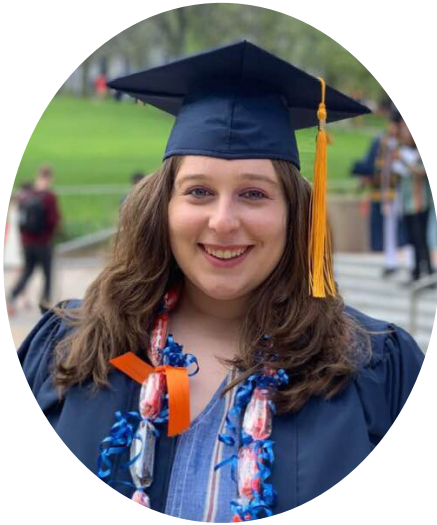
career as a registered nurse and then as a volunteer with the Westbury schools, among other organizations. The couple has been happily married for 36 years.

North Shore Child & Family Guidance Center provides help for the very youngest clients at our Marks Family Right from the Start 0-3 + Center (RFTS) in Manhasset.

All of the programs at RFTS are led by Dr. Sue Cohen, Director of Early Childhood and Psychological Services, who has been with the Guidance Center since 1991.

"This was my first job," says Cohen, who received her Ph.D. in Clinical Psychology from St. John's University. "My passion has always been working with young children, infants and their parents."

Very often, the mode of treatment involves play therapy. "Play is a child's main way of learning and communicating," says Cohen. "We think outside the box and use lots of creative means of relating to the child."

Cohen also runs a group called GASAK, for Grandparent Advocates Supporting Autistic Kids (see cover story). "We sometimes bring in a speaker from a local support program or an educational advocate or lawyer who can provide information to the grandparents," she explains. The grandparents often struggle when learning of a diagnosis of Autism Spectrum Disorder and find comfort in knowing that others share their experiences.

What makes the Guidance Center such a great place isn't only its services; it's the people who work here, says Cohen. "We have a dedicated and passionate staff that is always looking for creative ways to help our children and their families."

## Self-Care for Caregivers

Each year, North Shore Child & Family Guidance Center sets aside one day for staff to participate in workshops and bond with co-workers.

This year, our morning session was a hands-on learning experience as staff members learned CPR and other life-saving skills.

"Even though you hope that you will never have to use these skills, it's important to know them in case of an emergency," says Andrew Malekoff, Executive Director of the Guidance Center. "I'm very proud of how our staff took on this challenge."

In the afternoon, Nassau County Police Officer Ken Murray of the Nassau County Police Department's division of Homeland Security returned for the second year in a row to talk about "How to Psychologically Prepare to be a First Responder."

Officer Murray explained that first responders aren't just police officers, EMTs and firefighters, but also mental health providers. "You're just as critical a component in a crisis as any first responder," he told the staff. "Psychological wounds don't go away with a bandage, and without your help, none of this works."

He encouraged staff members to not only provide therapeutic services but to seek them out, since the work can be intense. He asked, "How many of you have heard things that no human should ever have to hear," and hands went up all around the room.

Regina Barros-Rivera, Associate Executive Director of the Guidance Center, said that Officer Murray did a terrific job speaking with the staff about our role as mental health first responders and the need for us

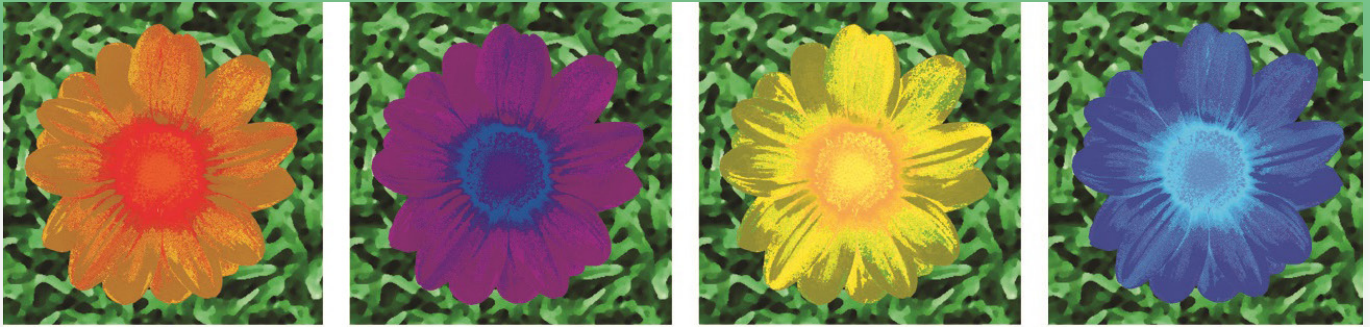

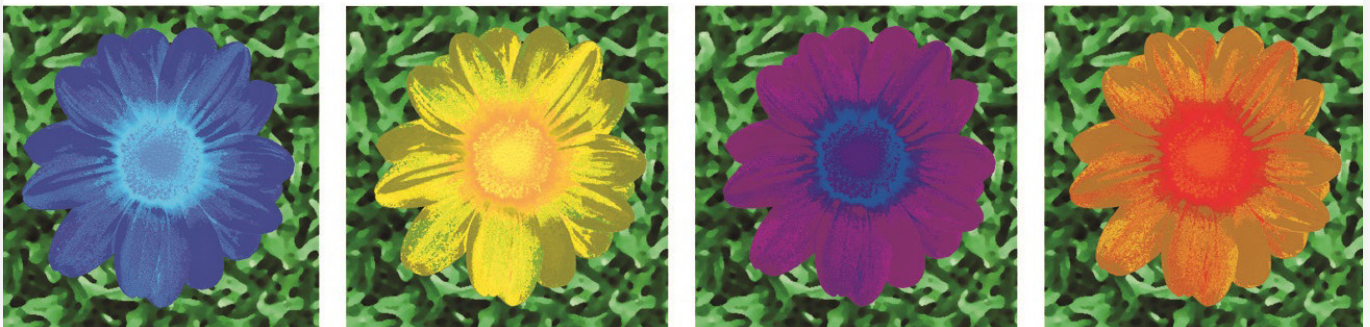

## IRA Charitable GIFTING: TAX-WISE OPTION

If you are 70 ½ or older, you can make a charitable gift directly from your IRA **without paying income tax on the withdrawal.**

### *How it Works:*

Susan and Jack have \$500,000 in an IRA. They don't need the entire \$24,600+ they're required to take this year, and they're not too happy when they think of paying all that tax. Susan and Jack have also been considering a substantial gift to support North Shore Child & Family Guidance Center. So they authorize the administrator of their IRA to transfer \$20,000 to the Guidance Center and \$5,000 to themselves. The \$20,000 counts toward their annual minimum required distribution, plus they avoid having to pay tax on it.

### *Your Benefits*

- ▶ You can transfer up to \$100,000 per year to charitable organizations.
- ▶ The charitable deduction counts toward your Required Minimum Distribution for the year.
- ▶ The amount transferred is excluded from your adjusted gross income.

### *To Qualify:*

- ▶ You must be age 70 ½ or older at the time of the gift.
- ▶ Transfers must be made directly from a traditional IRA by your IRA administrator.
- ▶ Gifts must be outright and the donor cannot receive any goods or services in exchange for their contribution.

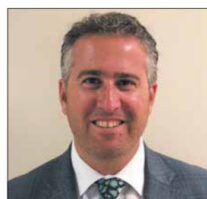

### Insurers failing to cover mental health

The law to require mental health education in New York schools is a good step ["LI Schools' New Focus on Mental Health," News, Nov. 28]. However, almost half of all children in the country with a mental health disorder did not receive necessary care from a mental health professional in 2016 according to the Journal of the American Medical Association.

We educate children to spot signs and symptoms and find resources – and then, in a cruel twist, many cannot access care.

Federal law requires insurers to treat mental health benefits the same as medical benefits, and to provide enrollees with timely access to a sufficient number of suitable mental health providers. This is known as network adequacy.

Too often, this does not happen, especially for middle-class and working-poor families because health insurers pay substandard rates of reimbursement for mental health care, thus depleting the networks. When families call for help, they are too often told, "I don't accept your insurance."

The health insurance industry does not comply with federal parity, and New York State does not adequately enforce the law. The state mandates mental health education in schools and lets the health insurance industry slide.

What do our kids learn? Once stigma is lifted, discrimination kicks in.

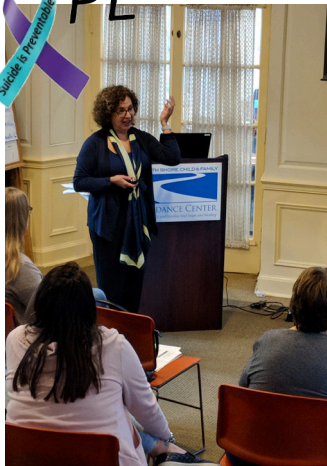

# Professional Workshops

## Sharing the Knowledge

North Shore Child & Family Guidance Center staff presents workshops year-round to provide information to other team members as well as outside mental health professionals. Here are some of the events this past fall.

Associate Executive Director Regina Barros-Rivera gave a workshop on “Latina Girls at Risk for Suicide and Other Self-Harming Behaviors” at the Guidance Center in October. Barros-Rivera created our Latina Girls Project, which provides bilingual individual and family counseling and monthly outings for adolescent girls suffering from depression and other issues.

Andrew Malekoff, our Executive Director, presented “Planning for Successful Groups.” He is the author of the internationally acclaimed *Group Work with Adolescents: Principles and Practice* (Guilford Press), now available in its 3rd Edition, and has taught at Adelphi University and NYU.



We hosted a new workshop this fall titled “An Introduction to Cognitive Behavioral Therapy with Adolescents.” Erika Orbon, a licensed mental health counselor at our Intensive Support Program (ISP) at B.O.C.E.S. Jerusalem Avenue Elementary School in North Bellmore, was the presenter.

Dr. Reena Nandi, the Guidance Center’s Director of Psychiatry, gave a workshop called “An Introduction to Child and Adolescent Psychiatry for Non-MDs.” Dr. Nandi has been on our staff since 1997 and presents this workshop regularly.

Finally, Jennifer Pearlman, licensed mental health counselor and Clinical Program Supervisor at Jerusalem Elementary School ISP, presented a new workshop, “An Introduction to Childhood Trauma.”
