Birth Equity

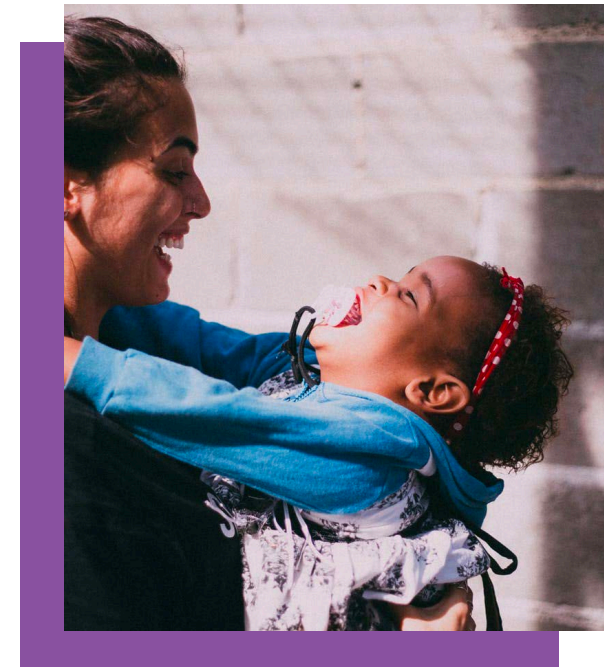
In certain Nassau County communities, black infants and their mothers have a higher rate of mortality than in the rest of the region.
